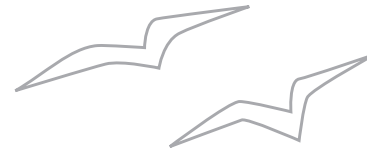

What is MIPI?

MIPI is a Documentation Centre on Children and Youth in Greenland. The purpose of MIPI is to gather, generate, and disseminate knowledge of the living conditions of children and youth in order to ensure that decisions and initiatives concerning children and youth are based on documented knowledge. MIPI gathers information pertaining to the child, e.g. on family, social matters, health, school, and accommodation. MIPI was founded as a consequence of Act of Parliament (Landstingslov) no. 26 which was passed on December 18, 2003. The Act of Parliament (Landstingslov) is available in its entirety at www.mipi.gl.

The board

The Documentation Centre is under the leadership of a board appointed by the Home Rule Government.

The following enterprises nominate members to the MIPI board: Ilisimatusarfik – University of Greenland, National Library of Greenland/Groenlandica, Statistics Greenland, Association of Municipalities in Greenland as well as those members of the Home Rule Government whose fields of responsibility count day-care centers, schools, health, prevention, and social matters. The head of the board is appointed among the nominated members.

MIPI's secretariat

The MIPI secretariat consists of an executive academic employee, an AC-employee and a student assistant as well as various project-associated researchers.

Who may use MIPI?

- Decision-makers dealing with the field of children and youth
- Politicians and the general public
- People engaged in practical work with children and youth
- Researchers and students

MIPI responds to inquiries and questions free of charge. However, more complex requests from public or private enterprises such as memorandums and documentation are handled for payment.

What does MIPI do?

- We help ensure that decisions and initiatives concerning children and youth are based on documented knowledge
- We organize public meetings and debates about relevant topics concerning children and youth
- We compile and disseminate knowledge of children and youth
- We lay the grounds for and facilitate a comprehensive and more solid knowledge of children and youth
- We publish an electronic newsletter four times a year

MIPI's publications

Every other year, MIPI publishes a statistic on children and young people. It consists of a body and a theme section featuring varying themes.

In addition, MIPI has published e.g. *Children and youth in Greenland – an anthology*, the report series *Children's standard of living in Greenland*, and two memorandums: *Memorandum concerning youth with a high level of well-being* and *Memorandum on suicidal ideations and suicide attempts among youth in Greenland*.
